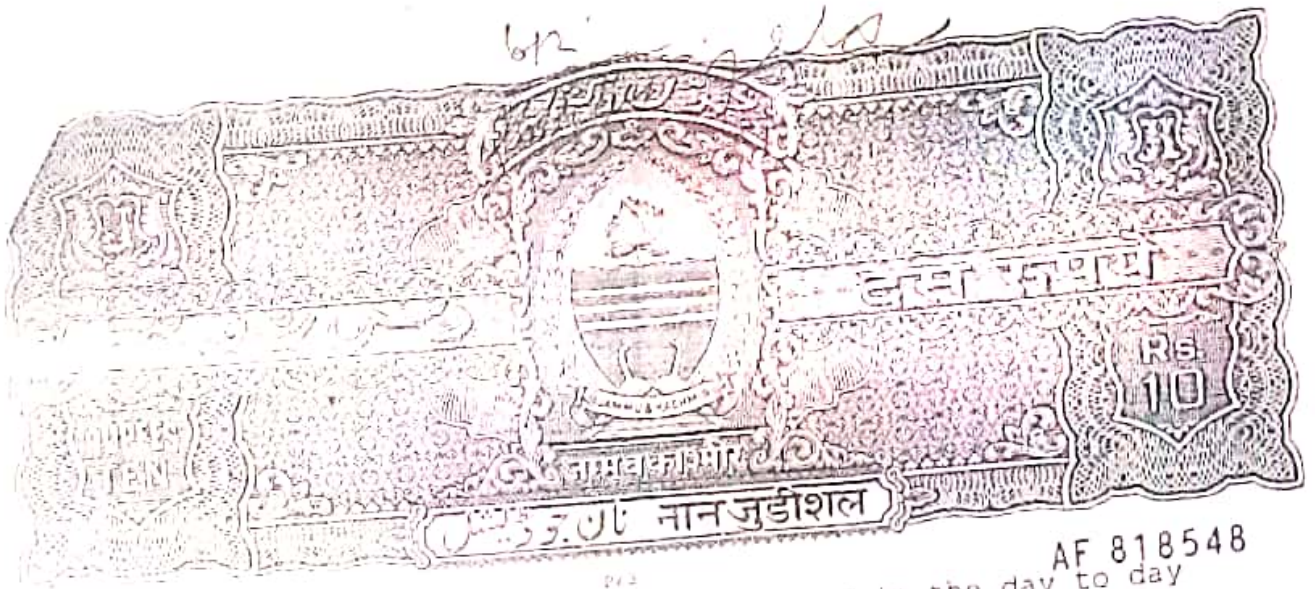

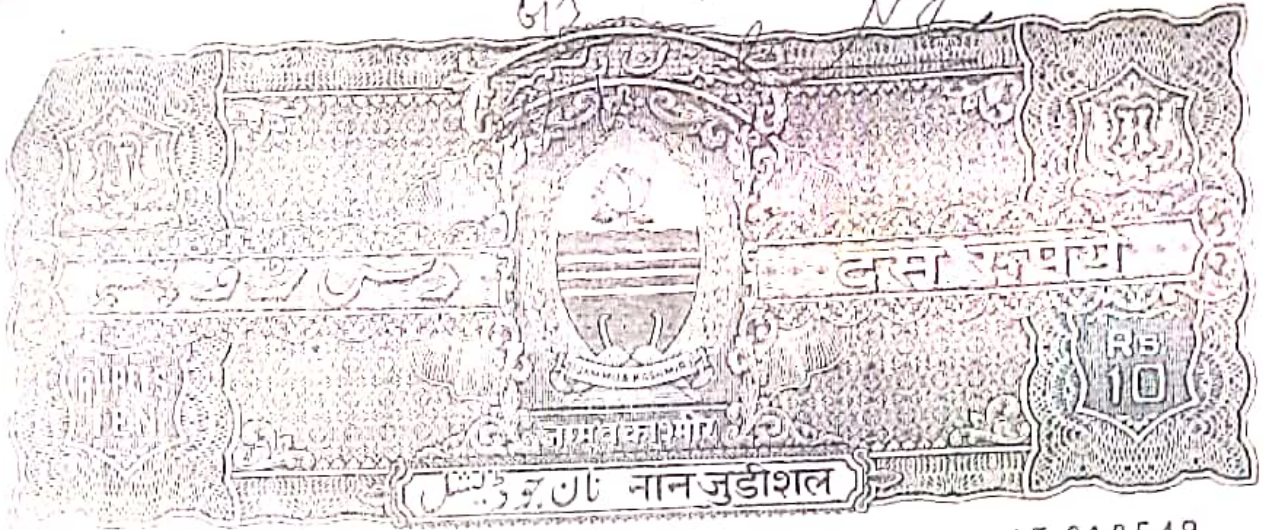
Working:-

- Every member stands or is liable to be disqualified if he/she.
 - Attains an age of more than 35 years.
 - Is involved in criminal activities or works against interests of the trust.

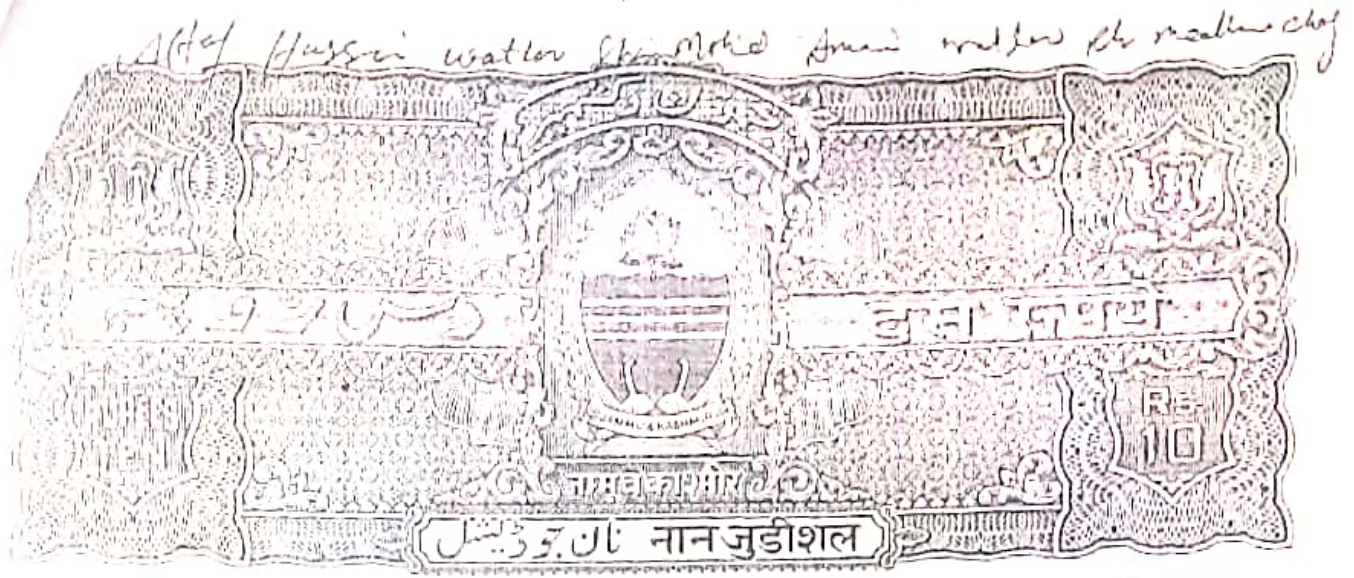
General Body:-

All the trustees & members shall constitute general body of trust having following function.

Functions of General Body:-

- The annual action plan & annual budget shall be placed before the general body for approval.
- Accounts for the previous year must be passed by this body

- It shall also amend or alter the constitution/procedure of trust as & when the need arises & the two third majority approves.

GOVERNING BODY:

It shall be elected by general body annually at a meeting for the purpose of election. The election commission shall also be appointed by two third majority prior to election.

- It shall be consisted of:-

(1) President (2) Vice president (3) Secretary (4) Treasurer.

The name & particulars of each office bearer of governing body shall be maintained in first schedule of this deed. A fresh first schedule shall be annexed to this deed annually after elections.

FUNCTIONS OF THE GOVERNING BODY:-

- Policy making.
➤ Implementation of the programmes.
➤ Administration.

OFFICE BEARERS.

1. The president:-

It shall be elected annually by a majority of the members at a general body meeting for the purpose of the election, at least 3/4th of the total members of

the general body must be present.

(1) Functions:-

- > To preside over & conduct meetings according to accepted parliamentary procedure.
- > Call special meetings.
- > To appoint sub-committees.
- > To represent & speak on occasions.

(2) The Vice President:-

- > The vice president shall be elected in the same way as the president. The function of vice president shall be:
 - > To assist the president.
 - > To be associated with the work of various committees.
 - > To preside over the meeting in the absence of the president.

(3) The secretary:-

- > The secretary shall be elected by a simple majority of members present in the meeting for this purpose. The function of secretary shall be:
 - > To prepare and read the minutes of the meetings.
 - > To attend the official correspondence.
 - > To send out and post the notices.
 - > To keep the permanent records.

The treasurer shall be elected annually by a majority vote of the body. The functions of treasurer shall be:-

- > To act as an custodian of the funds.
- > To receive & collect membership dues.
- > To assist in preparing of an annual budget estimated receipts and expenditure.
- > To keep the financial records.
- > To cooperate with the secretary in keeping an accurate membership role.
- > To prepare financial statements & reports.
- > To build up the financial standings.

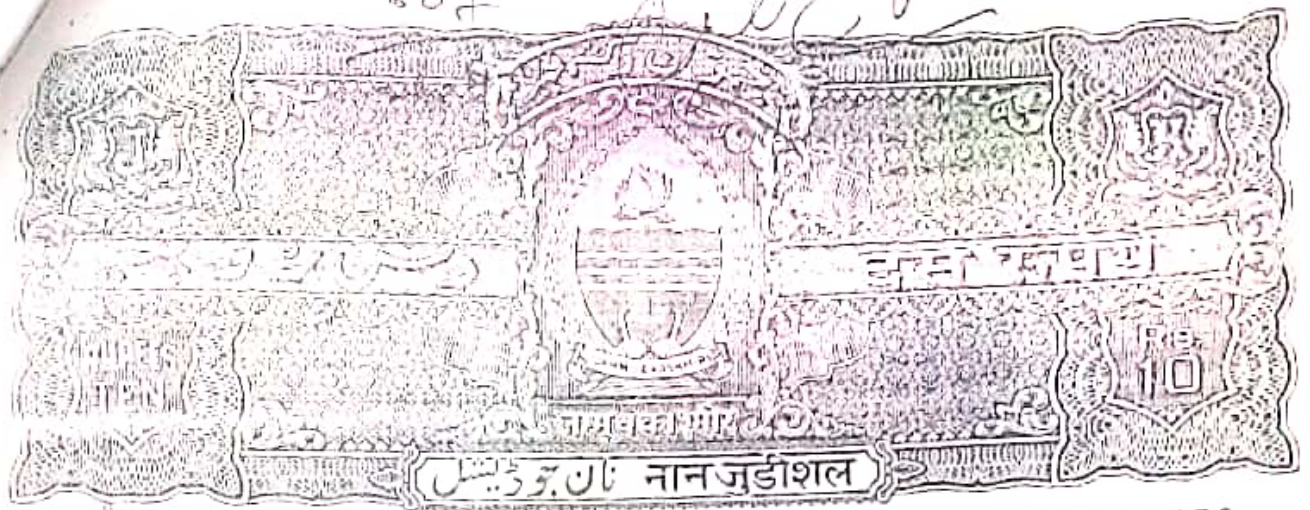
REMOVAL OF OFFICE BEARERS:-

- > Criminal convictions in the court of law.

- > Failure to discharge the duties conferred upon him by virtue of the office.

Intervention of the Court:-

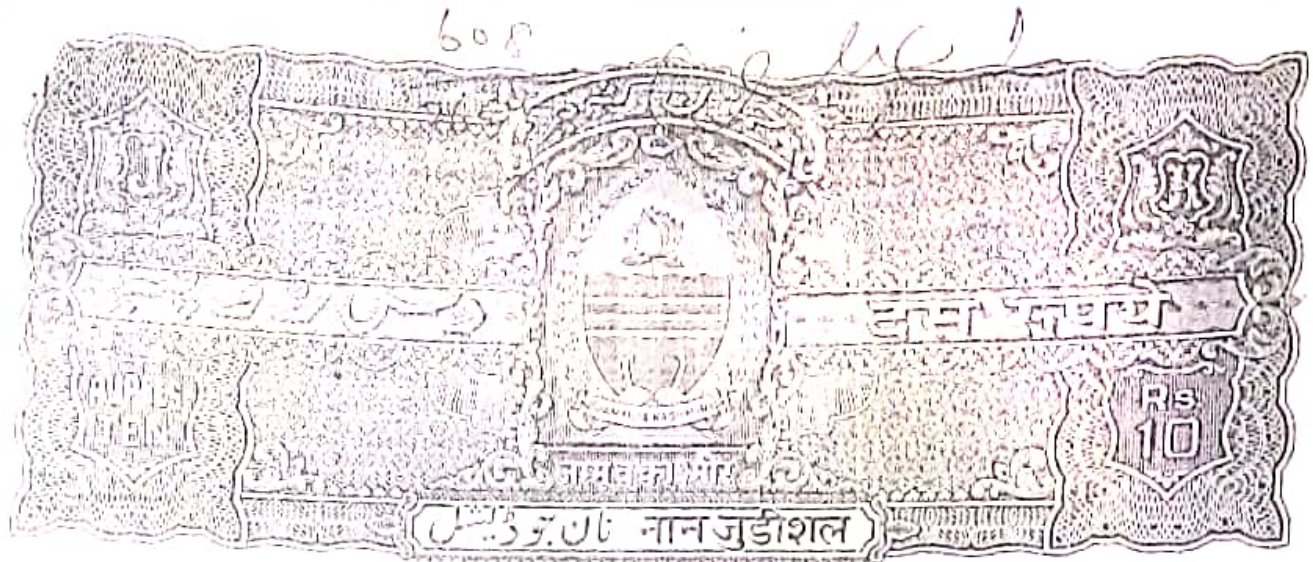
The court may intervene where.
